Dear Terry,

To successfully achieve these goals, the City will need to evaluate information and proposals from broadband providers to determine how each response meets the overall goals of the project and the needs of the community. As the City moves forward with the potential respondent(s), the City will need to navigate key P3 issues to protect the public interest and ensure that the private partner meets the needs of the community. This includes evaluating the capabilities of private service providers from technical, operational, business organizational and financial perspectives to ensure that the potential partnership(s) developed between the City and provider(s) are well aligned.

Magellan Advisors has significant experience representing public organizations in broadband RFI, RFP and ITN ("Invitation to Negotiate") solicitations.
